### Mare Handling and/or Boarding Agreement - 2021

This is an agreement between \_\_\_\_\_ and Raise The Bar Performance Horses, LLC (RTBPH) for the handling and/or care of the mare, \_\_\_\_\_ (and foal, if applicable) for any or all of the following services: boarding, foaling, and/or breeding.

1. Upon arrival, the Mare (and foal) will be in healthy physical condition and sound breeding condition (if applicable), free from any infections, contagious, or transmittable disease.
2. Copies of Health Papers, Registration Papers, and a current Clean Culture will be required before Mare can be admitted to the barn.
3. RTBPH agree to provide suitable facilities for the care of the mare (and foal). The Mare Owner agrees to pay for services as follows:
  - Dry Mare Care \$15/day
  - Wet Mare Care \$20/day
  - \$300 Foaling Fee
  - Special Needs mares \$25/day
    - For Mares being bred to one of our stallions; \$350 which includes the Collection, first Insemination, ovulation agent, and all ultrasounds (per cycle). If an additional Collection is needed for breeding during same cycle, it is an additional \$100, and second insemination is included into this cost.
    - If an additional Insemination is needed in same cycle the fee is \$50 per additional insemination.
  - For Mare being bred to an Outside Stallion with Overnight Shipping; \$400 which includes the Ordering of Semen, first Insemination, ovulation agent, and all ultrasounds (per cycle). This also includes the shipping to return the semen container (if semen is shipped in a disposable shipping container) and additional \$25 will be applied if shipping back an Equitainer.
    - If an additional Insemination is needed in same cycle the fee is \$50 per additional insemination.
  - For Mare(s) being bred to an Outside Stallion with Same Day (Counter to Counter) Shipping; \$500 which includes the Ordering of Semen, Picking up at airport, first Insemination, ovulation agent, and all ultrasounds (per cycle). This

also includes the shipping to return the semen container (if semen is shipped in a disposable shipping container), an additional \$25 will be applied if shipping back an Equitainer.

- If an additional Insemination is needed in same cycle the fee is \$50 per additional insemination.
4. Each Mare that is admitted to RTBPH for Foaling is under a camera 24/7, we monitor all night and we are present for foaling. All foals will get adequate attention, we navel dip and spray hooves with iodine for treatment against Navel Ill.
- We, at RTBPH, highly recommend each foal has an IgG test done between 12-16 hours after birth. This will be done at Mare Owners expense using RTBPH's Veterinarian. Mare Owner sign here if wanted: \_\_\_\_\_.
  - We, at RTBPH, highly recommend each foal is given Plasma, no matter the result of the IgG test, as Rhodococcus Bacteria may be present in our ground. The fee for this is approximately \$350 plus the farm call of \$65 from our Veterinarian. (This fee will be paid to Veterinarian and not to RTBPH). Mare Owner sign here if wanted:

5. RTBPH highly suggest that every foal that will be coming along side a Mare to be bred here, receive Plasma, for Rhodococcus 12-16 hours after foaling, as a precaution. If Foal did not receive plasma, please let us know so that foal is kept inside and not turned out at all, besides in our indoor arena, during its stay here at RTBPH.
6. RTBPH can manage your Mare for Embryo Transfers as well. Prices would be as follows;
- \$750 Enrollment Fee per Donor Mare – this is for us managing recips for your mare and ensuring we have a recip to suit your mare.
  - \$2,000 Recip Lease Fee – Due when the recip mare checks in foal with a heartbeat at 30 days.
  - \$15/day board starts on recip mare on day 31 of pregnancy and can be picked up at this time.
  - Prices include the first flush and transfer for the Donor Mare. If no embryo is recovered, then a second cycle management fee along with a \$400 fee for flushing.
  - Recipient Mare must be returned to RTBPH by November 1, 2022.
    - If Recipient Mare is returned in poor condition you will be charged \$750.
    - If Recipient Mare is not returned to RTBPH by November 1, 2022, you will be charged \$1500 for the mare.

7. Extra fees that may be applicable to Mare Owners from RTBPH would be as follows;
  - \$10 for Lutalyse injection
  - \$50 for Deslorelin (ovulation agent) injection
  - \$30 for Sedation injection (if needed)
  - \$25 for Staples (if needed)
  - \$30 for Opening Caslicks (if needed)
  - \$5/day for Regumate (if needed)
  - \$10 Banamine injection (if needed)
8. If RTBPH is unable to obtain a pregnancy after two attempts on Mare, RTBPH recommends that the Mare Owner have a Veterinarian do a breeding exam on mare, at Mare Owners expense.
9. Waiver of Liability. The Mare Owner agrees to assume all risk of death, sickness, or injury to the mare (and foal) except such harm as may be caused by the grossly negligent or reckless conduct of RTBPH, its agents, or employees.
10. In the case of an Emergency situation either during the pregnancy or during the foaling process, what number are we to call at any hour of the day? \_\_\_\_\_.  
If we are unable to get in contact with you within the amount of time we have to make a crucial decision, which one would you prefer we try to save, the Mare or the Foal? \_\_\_\_\_.  
We hope to never have to use this option, however things happen, and things can go wrong, and you may not have a long period of time to make a decision, so we want to be ahead of things and have a plan in place.
11. If Foal is born with contracted tendons, do you wish to have RTBPH put a temporary splint on foal and have a Veterinarian called out the following day or later that same day, depending on what time foal is born? \_\_\_\_\_.
12. If RTBPH feels the foal and/or mare need to be seen by a Veterinarian and can not get in contact with the Mare and Foal Owner, RTBPH has the right to call a Veterinarian out and the Mare and Foal Owner will be responsible for the entire bill. In this case RTBPH will only have the Veterinarian due what is necessary to keep Mare and/or Foal comfortable until the Owner can be reached. Initial here \_\_\_\_\_.
13. If RTBPH can not get in contact with the Mare and/or Foal Owner in an emergency situation, do you wish to have RTBPH do all that is necessary to try to save the Mare? \_\_\_\_\_.

14. If Mare is being boarded here at RTBPH long term (over 90 days), RTBPH will cut cost down to our normal Boarding rates; \$250/month in group pasture or \$300/month in a private lot. If mare needs to be grained, then she will go into a private lot and will be charged either an additional \$50/month for 5lbs of grain daily or \$100/month for 10lbs of grain daily depending

on her needs. All Mares with a foal on side will go into a private lot and will be charged \$400/month which will include 10lbs of grain daily. While mare is in a stall and being monitored for foaling the normal Mare Care rates of \$15/day will apply, and while in after foaling, and being stalled until foal is able to be turned out at approximately 2 weeks of age, the normal \$20/day will apply.

15. All care and bills must be paid **in full prior to moving the mare** (and foal) and/or recipient mare (if applicable). All unpaid balances are subject to 1.5% interest rate starting after 60 days. There will be a \$50 charge for bad checks.
